ORDER:

In compliance with the orders of Hon'ble Supreme Court of India and Hon'ble High Court for the State of Andhra Pradesh and Telangana, in the references 1st to 3rd read above, the Government of Andhra Pradesh have framed Rules on Police Complaints Authority i.e., "The Andhra Pradesh State/ District Level Police Complaints Authority (Administration and Procedure) Rules, 2022" vide G.O. 5th read above. The District Police Complaints Authority shall consist of one retired District Judge who shall act as Chairman of the District Police Complaints Authority and he will be assisted by three to five other members.

2. Accordingly, Government after careful examination of the matter and taking into consideration of panel of names proposed in the reference 6th read above, hereby appoint the following as Chairman to Four (4) District Police Complaints Authorities in the State for a period of three years from the date of taking charge of the Office and they shall be paid remuneration as per rule 4(c) of the Andhra Pradesh State/ District Level Police Complaints Authority (Administration and Procedure) Rules, 2022:
