#### **ORDER:**

In the G.O. 1<sup>st</sup> read above, Government have framed rules namely "The Andhra Pradesh State/ District Level Police Complaints Authority (Administration and Procedure) Rules, 2022".

- 2. In the  $G.O.2^{nd}$  and  $3^{rd}$  read above, Government have appointed the Chairperson to the State Police Complaints Authority (SPCA) and the Chairmen to (4) District Police Complaints Authorities (DPCA). The Members to the State Police Complaints Authority and District Police Complaints Authorities were appointed vide  $G.O.4^{th}$  read above.
- 3. As per rule at para-4(c) of the G.O.1st read above, the **remuneration**: Chairman of State/District Police Complaints Authority and if the member is a retired employee, he shall be paid remuneration equal to the last salary drawn minus pension or a consolidated amount fixed by the Government.
- 4. Government after careful examination, hereby fix the remuneration as consolidated amount to the Chairman and Members of the State Police Complaints Authority and Chairman and Members of (4) District Police Complaints Authorities as follows:
