NOTES

Note - 1	The order in this Warrant of Precedence is meant for State and Ceremonial Occasions and has no application in the day to day business of Government.
Note - 2	Persons in this Warrant of Precedence will take rank in order of the number of the articles. The entries in the same article are arranged in two Sections, persons from state Government and next person from Government of India. Those included in the same article will take precedence inter-se- according to the date of entry into that article. However, where the dignitaries of different States and Union territories included in the same article are present at a function outside their States or Union territories and there is difficulty in ascertaining their dates of entry, they may be assigned precedence as determined according to the date of entry into that article.
Note – 3	Except in the case of Ladies who hold a post mentioned in the Warrant of Precedence all other ladies will take their places along with their husbands in their respective Warrant of Precedence
Note – 4	<u>In Article 7</u> , the Chief Minister will take precedence over the Cabinet Ministers of the Union in official functions held in the State.
Note – 5	In Article 8:
	 a) Ambassadors Extraordinary and Plan plenipotentiary and High Commissioners of Common Wealth Countries accredited Indian will en block rank above Governors of States outside their respective States. b) Governors of states outside their respective States will en block rank above the Chief Ministers of states outside their States.
Note – 6	The Ministry of External Affairs may assign appropriate rank to foreign dignitaries and Indian Ambassadors, High Commissioners and Ministers Plenipotentiary during their visits to India.
Note - 7	Notwithstanding the procedure laid down in Note 2, the rank inter se and precedence of the persons in Article 10 shall be assigned in the following order:
	1) Deputy Chairman, Rajya Sabha
	2) Deputy Speaker, Lok Sabha
	 Ministers of State of the Union and any other Minister in the Ministry of Defence for defence matters.
	4) Deputy Chief Ministers of A.P.
	5) Members of NITI, Aayog.

Note - 8	In Article 14:
Note - 8	a) Chairmen of State Legislative Councils will rank above the speaker and Chief Justice of High Court will take precedence over the Lok-Ayukta for the State of Andhra Pradesh b) The Constitutional appointees viz., Chairmen, Speaker and Chief Justice of the High Court will take precedence over the Lok-Ayukta for the State of Andhra Pradesh and
	c) The Leader of Opposition in Andhra Pradesh Legislative Assembly will take precedence after all other in that article.
Note – 9	In article 18: Chief Whip Andhra Pradesh Legislative Assembly will take precedence below the Ministers of State of States in the article.
Note – 10	In article 19: Government whips, Andhra Pradesh Legislative Assembly will take precedence above Deputy Ministers in that Article.
Note - 11	<u>In Article 21</u> : The members of Legislative Assembly who happen to be invited to the following Order:
	a) Members of Rajya Sabha. b) Members of Lok Sabha. c) Members of Legislative Council d) Members of Legislative Assembly. The following members of each House may however, take precedence over other Members of that House. a) Floor Leaders of Oppositions Parties; and
	b) Ex - Ministers , Leader of Largest Opposition Group in APLC / APLA will take precedence above all other Members
Note - 12	In article 23:
	a) Secretaries in the Ministry of External Affairs other than foreign Secretary between themselves will take precedence in the order of their seniority in Grade -I of the Indian Foreign Service and both of them will take precedence after the Foreign Secretary.
	b) Members of the Minorities Commission and the Scheduled Castes and Scheduled Tribes Commission will always take precedence over the Secretaries of these Commissions.
Note – 13	Article 24:
	Members of Andhra Pradesh Administrative Tribunal will take precedence after the Retired Chief Secretaries to Government in that Article.
Note – 14	<u>In Article 25</u> :
	a) Additional Secretaries in the Ministry of External Affairs among themselves will take precedence in the order of their seniority in Grade-II of the Indian Foreign Service;
	b) Additional Solicitor General will take precedence above the Advocate General of State.
